Versatile Trailers, Inc. here warrants that each Versatile trailer operated by the original purchaser under normal use in the Continental United States or Canada will be free from defects in materials and workmanship for Three (3) years following the original purchase, subject to the requirements, exclusions and limitations stated below which will be strictly applied. If the trailer is rented or used for commercial hauling, this Limited Warranty is null and void. Versatile Trailers warrants the structure of each Versatile trailer to be free of defects in materials and workmanship, under normal use and service (carrying loads within stated capacity of trailer) for a period of three (3) years beginning on the Warranty Start Date. This limited 3-year warranty covers the structure only. The structure includes and is limited to the main frame of the trailer, which includes frame rails, tongue or neck, and cross-members.

CUSTOMER RESPONSIBILITY

In order to validate this Limited Warranty, the filled-out Warranty Registration form must be postmarked and mailed to **Versatile Trailers, Inc. 247 Kester Road, Roseburg, OR 97470** no later than Twenty 20 days following the purchase of your Versatile trailer. IF THIS SIGNED WARRANTY REGISTRATION IS NOT POSTMARKED BY THE 20TH DAY AFTER THE PURCHASE DATE, ALL EXPRESS WARRANTIES CONTAINED IN THIS LIMITED WARRANTY SHALL BE NULL AND VOID.

THREE YEAR LIMITED WARRANTY

Subject to the requirements, exclusions and limitations stated below, the structure of your Versatile trailer is warranted to the original retail purchaser against any defect in the materials and workmanship by Versatile Trailers, Inc. arising from normal use for three (3) years from the date of purchase. The structure is that portion of the trailer which includes the main frame, consisting of the bottom rails, cross members, side posts and exterior walls, and the subframe, excluding the floorboards and running gears.

Subject to the requirements, exclusions and limitations stated below, all other components of your Versatile trailer are warranted to the original retail purchaser against any defect in the materials and workmanship by Versatile Trailers, Inc. arising from normal use for three (3) years from the date of purchase.

LIMITED PAINT WARRANTY

Versatile Trailers, Inc. warrants the paint finish to be consistent with industry standards for *one (1) year* after the original retail purchase, with the exceptions of "normal use" limitations set forth below and of deterioration due to use or exposure, such as chipping, scratching, fading, cracks in caulk seam, road salt or tar, damage by animals, pressure washing and loading or unloading. Warrantable paint repairs are limited to spot repairs and blending consistent with standards in the trailer industry. PLEASE NOTE THAT PAINT REQUIRES 30 DAYS OF CURE TIME.

EXCLUSION OF COMPONENTS WARRANTED BY OTHER MANUFACTURERS

Tires, axles, and brake components, springs and suspension components, coupler, jacks, castors, batteries, and lights purchased and installed by Fabform Industries, Inc. are warranted by their manufacturers and are excluded from this Limited Warranty.

HIGH PRIORITY: BURNISHING BRAKES BEFORE FULLY OPERATIONAL

Our Top priority is ensuring safety. Please note that all electric brakes must undergo burnishing to achieve full functionality. Until this crucial process is completed, trailers may exhibit limited braking ability. Your safety in our highest priority, so we strongly recommend adhering to this requirement before using the trailer.

NORMAL USE, NO REPAIRS OR ALTERATIONS

By signing the Warranty Registration, THE PURCHASER ACKNOWLEDGES THAT HE OR SHE HAS READ THE ABOVE LIMITED WARRANTY AND AGREES THAT, SHOULD ANY WARRANTY CLAIMS BE MADE BY PURCHASER, PURCHASER WILL FOLLOW PROCEDURES AS SET FORTH ON THIS FORM.

DEALER RESPONSIBILITIES

Versatile Trailers, Inc.'s Dealer is responsible for "dealer prep" which includes checking all cosmetic features and repairing all minor problems without charge to you or the manufacturer.

Your dealer is also responsible for submitting to the manufacturer any claim you wish to make under the terms of this Limited Warranty.

REQUIRED WARRANTY CLAIM PROCEDURE

- 1) In order to validate this Limited Warranty, the Warranty Registration must be postmarked to Versatile Trailers, Inc., no later than twenty (20) days following the purchase of your Versatile trailer.
- IF THE WARRANTY IS NOT SIGNED, POSTMARKED AND MAILED TO VERSATILE TRAILERS, INC. BY THE 20TH DAY AFTER YOUR PURCHASE OF THE TRAILER. ALL EXPRESS WARRANTIES SHALL BE NULL AND VOID.
- 2) Within five (5) days after discovering a problem with your Versatile trailer, return your trailer for inspection to your Versatile Trailers, Inc.'s dealer where you purchased your trailer. Dealers are responsible for fixing minor problems without charge to you or the factory.
- 3) If your dealer cannot repair the problem free of charge and you want to file a claim under this Warranty, your local dealer must send to Versatile Trailers, Inc., by registered letter, or fax to 541-679-2921 with follow-up phone call to confirm receipt of fax, a claim form, together with all required information, within ten (10) days of your discovery of the defect.
- 4) Versatile Trailers, Inc. will acknowledge such receipt of claim to the dealer and to the claimant. Versatile Trailers, Inc. will respond as soon as possible, but no later than thirty (30) days after receipt of the claim.
- 5) Any defective part(s) must be sent by prepaid freight to Versatile Trailers, Inc. in order to qualify the claimant for replacement or reimbursement under this Limited Warranty. ANY DEFECTIVE PARTS MUST BE RETURNED TO FABFORM INDUSTRIES, INC. WITHIN 30 DAYS FROM THE DATE OF APPROVAL TO QUALIFY FOR REIMBURSEMENT.
- 6) Versatile Trailers, Inc. will not reimburse any claimant for any adjustment or repair of your Versatile trailer without prior written approval by Fabform Industries, Inc.
- 7) If you return your trailer for repair to the factory, Versatile Trailers Inc. will warrant the repair or replacement parts for one (1) year from the date of repair. If authorized repair must be done other than at the factory, Versatile Trailers, Inc. will not warrant such repair work or replacement.

8) Versatile Trailers, Inc. reserves the right to not pay unreasonable costs for replacement or repair of defects in Versatile trailers and may, at its discretion, establish a reasonable reimbursement for any authorized work performed under the terms of this Limited Warranty.
